# VCC Chef Instructors Declared World Champions

Culinary Team Canada won four gold medals and was acclaimed Caterplan World Culinary Champions, 2001 at Caterplan World Culinary Grand Prix March 12-15. Captained by **Glen O'Flaherty**, Chef Instructor at Vancouver Community College, the six member team which included **John Carlos Felicella**, also a VCC instructor, proved themselves to be among the world's leading chefs.

Caterplan World Culinary Grand Prix is the world's largest culinary competition in 2001 and is organized by the Federation of Chefs Scotland. Twelve national culinary teams - Canada, Czech Republic, Germany, Ireland, Iceland, Malta, Norway, Portugal, Russia, Scotland, Switzerland and the USA participated.

Teams were judged on a wide range of criteria including preparation, cleanliness, presentation and taste. They competed over two days to prepare an international cold buffet display and a three-course meal for 100 in the Restaurant of Nations competition.

Team Canada was proclaimed best overall and World Champions in 1997, triumphing over 20 other teams from five continents to win gold medals in both Restaurant of Nations and Cold Kitchen competition categories.

#### Valedictory Address (Academic/ASE/ABE division) Graduation March 2001

... Thanks, Mom and Dad.

Good evening honored guests, teachers, fellow grads, friends and families. I am pleased to be with you, and honored to be asked to speak to you tonight.

When I was a little girl, I remember standing at the bottom of a path that led to the top of a wooded hill. I was just curious enough to jump on that path and climb to the top of the hill, wondering what I would see on the other side.

Like some of us, I had a rough start in life. I was raised in a single-parent home with two older brothers. Times were hard financially for us but with my Mom's example of hard work and courage, both my brothers went back to school, went on to university, and got their doctorates. And being a girl in the 1960's, I was supposed to marry a good man who would take care of me...after all, girls don't do math.

Well, I didn't marry, I rebelled. Taking care of myself, I worked hard over the years. But in 1993, I injured myself on the job. After 7 years on a disability pension, I found that in order to return to work, I was under-educated and under-skilled for the competitiveness of today's work place. I was also bored and felt that I still had something to contribute to my society.

So, I took a d-e-e-e-p breath and last July, I registered for the Adult Basic Ed College and Careers Access program at VCC. Just three short months later, I wrote my GED exam and got my grade 12 equivalency - after 35 years! It seems that I have a gift for learning math, so I am staying on at Adult Basic Ed in order to upgrade my math skills and plan to continue in September with a 9-month career program at VCC. All because I was just curious enough to see what was on the other side....

And I am in good company. My fellow students come in all shapes and sizes, ages, backgrounds, and we make a diverse ethnic mix; our pre-exam potlucks are fantastic! In fact, our class Christmas party was the best party I've ever attended: students and teachers brought a bounty of ethnic food; there was a fun video to watch; we played lots of music, won prizes, received gifts, even danced the Macarena - teachers, too - no need for drugs nor booze, just

Respectful relationships develop in our supportive Adult Basic Ed program. This spirit of learning gives us added skills and confidence, with some of us confronting a sense of personal failure and overcoming a self-imposed limitation. It's been harder for me to return to school as an adult, but I have been able to overcome a math-phobia. Girls can do math. I can do math. I couldn't know that until I tried.

Every graduate here has succeeded, and tonight is a celebration of that success. We are just getting started: some of us will continue with our studies; some of us will go on to look for work; and some of us will take a break or rest. But none of us will ever be the same. If we are asked, let's share how it's been for us here, for we can now inspire others.

I'd like to close by sharing an anonymous quote with you, which gave me the courage to start the Adult Basic Ed program at VCC: "Ships in harbor are safe...but that's not what ships are built for".

I wish happy sailing and the best of luck to all the grads here tonight. I'd like to thank God, Vancouver Community College, my dear Adult Basic Ed teachers, who are, I believe, true educators, and my supportive and loving friends, all who helped me be here tonight. Thank you.





#### Your Community Wins When You Count Yourself In! Why Educators Should Care About The Census...

It's been around for 335 years, so it's easy to take it for granted. But the Census of Population, which will conducted by Statistics Canada in May of 2001, has an impact on everyone who lives in British Columbia.

Census information and its many uses affect educators, researchers and students. Consider this: for every

British Columbian not counted in the Census, the province loses \$1,000 per person annually in federal transfer payments. Millions of dollars for the province are at stake, with a portion of that money destined for post-secondary education. Census data are also a valuable resource for researchers and students, as there is no substitute for the detailed socioeconomic data from the Census.

In many areas of community planning, census data are crucial. Population characteristics of an area are used to plan for basic services and infrastructure such as schools, public transportation, day care, police and fire protection.

Census information also supports more than 80 provincial and federal legislative measures, including Employment Insurance, Canada Pension Plan, Child Tax Benefits and Old Age Security.

In the last Census in 1996, B.C. had the lowest mail returns of any province in Canada. When that happens, as a province we're not only affecting our chances of getting our fair share of the pie - more of our tax dollars will be spent on conducting the Census, since low mail returns mean census workers must spend extra time and money going door-to-door requesting completed forms.

Jim Selley, Director of Statistics Canada for the Pacific Region points out, "It's so clear that the Census benefits our province and communities. In the end, the Census isn't for Statistics Canada or for any government - it's for the people."



1. Wellness Incentive Program In order to encourage people to participate in activities leading to a healthy and balanced life, the VCC Wellness Committee developed a voluntary program where participants will be asked to track those

activities that help them achieve a sense of physical, mental, spiritual and emotional well-being. Each activity, depending on its form, is assigned a certain number of points. When an individual reaches a specified achievement level (1000 points, 2500 points and 5,000 points), the Human Resources Department will acknowledge the achievement through prize(s) and/or recognition in some form. The Council received background information on the program and were also asked to help encourage participation. The pilot program will be launched in the week of March 19th and will under go a six month review after implementation. Carol Sicoli of the Human Resources Department is coordinating the project.

2. College Planning Update

A report was distributed on planning activities. Members were asked to review the information and provide any comments to Deanna Rexe, Director of Institutional Research and College Planning.

3. Guidelines for Commercial **Privately Funded Activities** 

This item was deferred to the next meeting for final approval and discussion

4. Security Tender Process Update Larry Waddell advised that the Security Tender process closed on March 5th. The advisory committee reviewed the bids and made a recommendation to award the contract. The Finance Committee will review their recommendation on March 14th, after which the advisory committee will re-convene to discuss additional details relating to the final contract. It is expected that services under the new contractor will be in place by March 27th.

5. Assessment Fee

Increases Assessment fee increases as recommended by the Fees Committee was brought forward for approval. However, as there was not

a quorum present, the item was deferred to the next meeting.

6. Earthquake Preparedness The aftermath of the recent earthquake raised questions about how prepared the college community was to respond to this type of emergency. In VCC's Emergency Procedures Handbook, the outlined procedures provide guidelines on what to do but it was suggested that it may be valuable to provide hands-on training in each department. A suggestion was made that pictorial depictions which visually capture the procedures and then are posted in strategic locations and in all classrooms would be beneficial. Ongoing training would require identifying one person in the area who would undertake the responsibility of ensuring that instructors were aware of the procedures and informing students. Larry Waddell was asked to discuss the issues raised and suggestions with Steve Traviss, Health and Safety Coordinator, and provide feedback at the next Council meeting.

06. ForInformation: Sequencing changes have been made to the courses in the Hospitality Management Program.

A number of current requirements from the Canada Student Loan Act and the Canada Student Financial Assistance Act were brought to the attention of Education Council. The Student Services Branch (Loans) has requested input from stakeholders concerning on-line courses and their eligibility for full-time financial assistance.

Effective January 2002, GED examinations will be revised to better reflect standards required of a grade 12 student.

#### Special Announcement To Support Staff and Nurses Buyback of Pensionable Service Not Previously Allowed

The College has requested and just recently received approval from the Pension Corporation that allows support staff and nurses to purchase pensionable service when they were previously not allowed to contribute. To purchase service, you must be an active plan member contributing to the Municipal Pension Plan. The cost to purchase the service is based upon your current salary and current employee and employer contributory rates, and multiplied by the number of months of service you are purchasing.

#### You can purchase:

- service during your probationary period prior to your permanent appointment
- any part-time service for which contributions were not made
- service performed before 1988 for which you were not eligible to contribute because of age
- service or which you opted not to contribute, or
- service with any other employer within the Pension Corporation.

#### You cannot purchase:

- a period of time during which you were not employed, or
- service to "top-up" your part-time employment to make it full-time.

If you wish to purchase a period of service with a different employer, the cost is based on the actuarial value of the increase to the pension benefits as a result of the purchase of service. To purchase the service, you must pay the cost in a single payment for the total amount owed. Payment can either be by RRSP transfer, personal cheque or a combination. A tax receipt will be issued if you pay

If you are purchasing service on or after January 1, 1990, the Pension Corporation will calculate a Past Service Pension Adjustment (PSPA). Because a PSPA reduces your current RRSP contribution room, Canada Customs and Revenue Agency must determine the amount of RRSP contribution room available to you, to determine whether your purchase of service is allowable under current Retirement Savings Rules.

In some cases it may not be a substantial benefit to your pension to purchase additional service. Before calling or making a final decision, please read the information listed below.

The formula to calculate the cost to purchase service is:

Employee hired full-time on January 1, 1990 and wishes to buy their six month probationary period. Employee's current monthly salary is \$2,916.67 and the current employer rate is 6.27%.

 $.075 \times 2916.67 \times 6 = $1312.50$ 

Less .015 x 2916.67 x 3 = < \$131.25 >

Plus .0627 x 2916.67 x 6 = \$1097.25 = Estimated Cost = \$2278.50

Using the Pension Calculator, with the additional six months service works out to be:

Single Life Annuity Guaranteed 5 Years:	\$1320
Bridge Benefit (Offset):	\$714
Total (Monthly)	\$2034
Without the additional service, the pension works out to be:	
Single Life Annuity Guaranteed 5 Years:	\$1297
Bridge Benefit (Offset):	\$709

The purchase of 6 months service will increase the pension by \$28 per month (\$2034 - \$2006).
