## 1) PROFESSIONAL DEVELOPMENT LEAVE

Article VII C. 2.d of the current Collective Agreement between the College and the Vocational Instructors' Association of B.C. provides for a minimum of five (5) days' leave per year, with pay, for professional development purposes.

You are reminded that the "year" mentioned above is not a calendar year; rather, it is that year coincident with the duration of the Collective Agreement, namely April 1 to March 31 of the succeeding year.

When you apply for your Professional Development Leave, you must make a formal proposal for it, stating how the time will be used to your advantage and that of the College.

Upon return from leave, you must account for your activities during the leave.

Both your formal proposal and report must be submitted, via your department head, to the principal.

To facilitate processing, which includes finding, where needed, a suitable substitute, normally a month's notice is required.

Only rarely will an application received after January 31st be considered for the current leave year.

Without the written permission of the student concerned, the complete student's record, or portion thereof, will not be divulged to anyone (including parents) other than administrators and members of faculty at the College campus/centre concerned, and the College Principal or person(s) designated by him/her. Staff members, other than those employed in Student Services at the student's campus/centre, will not be permitted access to student records.

Staff members employed in Student Services at other College campuses/centres may exchange student information for the purpose of completion of data on students.

A student has the right to see his/her own record."


