## Dear Mrs Wakefield,

It's been five years since I was a restless but inspired student in your TEFL class at U.B.C. I wonder if you're still teaching at U.B.C and if you're still involved with Vancouver City College.

I left Vancouver in 1974 and after 41 years of T.E.F.L in Thailand I now find myself working for a refugee organization in Malaysia. My post is Kuala Trengganu and my job is supervise the movement of the refugees from Bidong Island to Kuala Lumpur where they are processed for movement to Canada, the USA and Europe.

There are 42,000 refugees on Bidong and most of them are anxious to learn English. To a TEFL teacher that's either a nightmare or a challenge. However, as anxious as they maybe, Bidong is incredibly crowded and so facilities are available for only 2000 students. By facilities I mean and so facilities are available for only 2000 students. By facilities I mean the classrooms (used on a shift basis) made of scrap wood, sticks and plastic sheets.

Though it is not one of my duties, I have become involved with their English Language program which is run entirely by refugees since no foreigners are allowed on the island. As none of the teachers have had any experience in teaching, I've begun training several of them in the art of T.F.F.L.

Unfortunately the time I can spend with these teachers is limited and they have no materials to work with nor any money to buy materials. Hence the point of my letter. Do you suppose that V.C.C or any other T.B.F.L outfit that you know of could donate some programed texts at the beginners level?.

The refugees on Bidong have the time and desire to study. In fact many will be on Bidong for a year or longer. They would be most appreciative of any donation be it one text or a hundred.

If you know any teachers or organizations willing to denate would you please have them send the materials to me at the above addresse

I hope you don't consider this request an imposition,



### 7) I.C.B.C. - STUDENT AUTO INSURANCE

Dear Mr. McNaughton:

Further to your recent telephone conversation senior officials have now reconsidered the position outlined in our letter of June 4, 1979.

You have requested an interpretation of the Autoplan rating requirements for students attending an educational institution who temporarily operate a vehicle in a territory rated differently from the geographic location which is used to calculate their insurance premium.

The words "principally used" in Section 2.16(a) of the Regulations pursuant to the Automobile Insurance Act are interpreted as "the greater number of days during the term of the Owner's Certificate".

Should the term represent three hundred and sixty-five days (365) and the vehicle is rated for Kelowna but the student attends an educational institute in Vancouver for one hundred and eighty-two days (182), a change in the rating territory would not be required.

However, should the period of use in Vancouver exceed the period of use in Kelowna, then the vehicle owner would be required to contact an Autoplan agent or Motor Vehicle Branch Office, and have the insurance premium amended to reflect the correct rating territory. Failure to do so, may prejudice an insured's right to indemnity under his/her Autoplan coverage.

Thank you for your interest and we trust this outline clarifies the points you have raised on this aspect of Autoplan coverage.
