1) COLLEGE BOARD MEETING

The Vancouver Community College Board met in regular session on Wednesday, September 12th.

College Principal A.S. Manera's report to the Board, covering a variety of items, has been placed in the library.

The College Board dealt with the following:

- a) Board Member J.M. Kennedy's report of the recent meetings of the Management Advisory Council and the Executive Committee thereof (of which Mr. Kennedy is chairman). Of interest was MAC's recognition of the "... particular kind of service ... " offered by King Edward Campus and that "... these services will probably continue to be in strong demand."
- b) Upon the request of the Minister, the Board approved the payment of \$4,700,000 to the Vancouver School Board for the transfer of title of Vancouver Vocational Institute and Langara Campus from V.S.B. to V.C.C.
- c) Mr. Manera reported that option documents for the China Creek site identified as a possible site for a new King Edward Campus have now been executed. To date, however, the Minister has not approved the purchase of the property as our new campus.
- d) By motion, the Board agreed to assume administrative responsibility for the B.C. Union Catalogue, as requested by the Minister.
- e) The Board approved the recommendations of the Institutional Research Task Force re the establishing of an Institutional Analysis and Planning Office (I.A.P.O.) subject to the availability of funds in the 1980-81 budget.

f) The Market Research Task Force completed its report last January and the Board, at Wednesday's meeting, approved the following resolution:

"... that the current flexibility of the College be maintained by conscious effort in order that the College may accommodate quickly to shifts and fluctuations in the educational needs and demands of the community. To this end, it is vital that no restrictive or cumbersome policies be established which could have the effect of reducing capability to react quickly. Fiscal policies such as use of contingency funds and a streamlined "Request for Additional Course" process, should reflect our ability to react quickly. Further, owing to the high percentage of part-time students (70%), flexibility in scheduling must be maintained."

g) College Bursar K.M. Fleming presented the financial report for the four-month period ending July 31, 1979 which showed K.E.C. as having overspent its budget by 1.1%. Mr. Fleming indicated, however, that the end-of-August figures indicated that expenditures matched revenue figures.

Minutes of the Board meeting of July 18, 1979, the report of the College Principal to the Board, with background material and supporting documentation relating to the agenda items have been placed in the library for the perusal of those interested.

18) CHAIRMAN, COMMUNICATION ARTS DIVISION


Interviews for the chairmanship of the Communication Arts Division took place this week Wednesday. The Recommendation Committee had three good applicants and interviewed each of them.

Re: Provincial Adult Basic Education Steering Committee

Approval has now been received to carry out a Provincial Adult Basic Education Literacy curriculum development project. The purpose of the project is to develop curriculum goals and guidelines and identify relevant materials for a Basic Literacy programme for the grades 1-8 equivalency level in British Columbia.

A Steering Committee is now being created. This committee, composed of eleven persons selected from around the province for their expertise in basic literacy programmes, will include personnel from cooperating school districts and colleges and will meet for the first time in early October.

Ms. Evelyn Battell of your college has been recommended as a member of this steering committee. The function of the steering committee is to advise project staff on a wide range of related matters and the agenda for the first meeting will include the following items:

- 1. Review an annotated bibliography of Adult Basic Education materials compiled by project staff.
- 2. Review and discuss selection of packaged materials.
- 3. Examine specimen curriculum guides prepared in other jurisdictions.

- 4. Discuss and determine a possible approach to a Basic Literacy programme for British Columbia.
- 5. Develop a preliminary set of goals for a basic literacy programme.

It should be emphasized that members of the Steering Committee will not be asked to develop curriculum guidelines and materials themselves, as a subsequent phase of the project will engage seconded instructors for that purpose.

Ms. Battell is among the outstanding Adult Basic Literacy practitioners in British Columbia and she will make a valuable contribution to this important process. The Ministry will pay all travel, accommodation and meals associated with this project. We are asking your institution to release your employee for a task which may entail some five to six days in the coming nine-month period.



4) PARKING


