COLLEGE BOARD MEETING, WEDNESDAY, JUNE 25

With a larger than usual public gallery made up mainly of Langara Campus administrators and division chairmen, there was a slight delay pending arrival of a quorum.

Mr. Manera presented the "Report of the College Principal" to the Board (copies are to be found in the Library). Of particular interest to K.E.C. were: Training and Development Division graduations; our increased enrolment from 3,976 in June 1979 to 4,735 in June 1980; English Language Training instruction to refugees; our needs for space with the Carnegie Centre no longer being available; and the Draft Policy on the provision of Adult Basic Education Programs.

R.A.C.'s were approved for English as a Second Language, English 10 Equivalency and B.T.S.D. Levels 2/3 (Native Indian Educational Centre).

In the Report on Facilities Planning for V.V.I., approval was given to relocate temporarily the Business Career programs so that the first stage of the new building can go ahead.

There was much discussion concerning the Child Care Centre for the new campus, during which Board Member Divinsky asked if arrangements could be made for him to meet Minister McCarthy so that he "could press her to the wall" as a means of getting help from the Ministry of Human Resources. This offer was accepted and attempts will be made for a meeting to take place. Mrs. Dean proposed that a committee be formed to look into the problem of Day Care at the Campus.

It was proposed by Mrs. Jervis that schematics be drawn by Mr. Howard for a 45 station Day Care Centre. Concensus was that the Day Care Centre not be included within the main building complex but contiguous to them.

Graduate follow-up data was provided for selected career and vocational programs at all three campuses. For King Edward Campus, data was provided for only the Homemaker and Pharmacy Assistant programs.

The Audited Financial Statement for the year ending March 31, 1980 was accepted.

The College officials were authorized to exercise options to purchase the China Creek property at a cost not to exceed \$5,150,000.

Request for Additional Courses for more than \$300,000 for extension of the programs for refugees at K.E.C. was accepted without question.

The Board approved an expenditure of \$281,355 for Word Processing, to be submitted for further approval by the Ministry of Education for funding through debentures.

The Board recommended acceptance of everything in the proposed 1981-82 Budgets, except \$38,500 for Placement Services at V.V.I.

The budget approved was:

\$39,790,029 for the essential budget; 1,127,186 for the desirable budget; 1,649,405 for the operating budget \$42,566,620 total

In closing, board member Sleigh stated that it was a good budget in terms of priorities and he expressed his recognition of all the hard work that had gone into its preparation at every level.

The next Board meetings will be on July 16 and August 20. You are all invited to attend.

Council approves campus move

Vancouver city council has approved Vancouver Community College's plan to move its King Edward campus to a 7.8-acre site at China Creek in the Mount Pleasant district.

Council accepted a rezoning application for the new \$22-million building following a sometimes heated two-hour public meeting Thursday at Queen Alexandra elementary school.

More than 100 people crowded the school's gymnasium to hear presentations from community groups, the college and architect Ron Howard.

Nine of 12 public presentations demanded the college include provision for day-care facilities for the new campus. An amendment by Ald. Harry Rankin to make the provision of a 45-unit day-care centre a condition of rezoning was defeated by a 5-4 margin.

The Civic Non-Partisan Association majority on council narrowly defeated Rankin's amendment, with only Ald. Bernice Gerard voting across party lines, joining Rankin, Darlene Marzari and Marguerite Ford. Mayor Jack Volrich and NPA Aldermen Don Bellamy, Helen Boyce, Warnett Kennedy and George Puil voted to defeat the amendment.

Another amendment by Ford to increase the college's off-street parking capacity minimum from 540 to 590 spaces also failed, Gerard voting with fellow NPA aldermen.

This was a victory for the college board of directors who felt conditional approval could delay or jeopardize the building of the campus.

"We're not opposed to the move as long as there is a guarantee for day care," said Dan O'Reilly of the Grandview-Woodland area council. "At a recent survey at the college, 44 per cent of faculty surveyed said they knew of students who missed class or dropped courses because of day-care problems."

Darlene Jewett, of the Eastside Single Parents Association, told council day-care facilities were already chronically inadequate in the area without adding the children of parents attending the college.

Other community group spokesmen criticized the college for ignoring day care, especially since community college's are supposed to provide openings for single parents and others using public assistance.

"I'm begging council to help the college in pursuing the matter so we can help those who need the help," said Patricia Kennedy, a faculty member at the King Edward campus.

College principal Tony Manera had earlier told the meeting that the college had unsuccessfully approached the ministries of education and human resources for funds to build a day-care facility.

Manera also said the facility would probably cost about \$250,000.

After the public presentations had ended, Mayor Jack Volrich unexpectedly allowed Alex Stusiak, president of the Vocational Instructors Association, to speak from the floor during council's debate. The meeting crupted into a loud shouting match over the mayor's ruling between Volrich and Ald. Rankin.

The education ministry has authorized the purchase of land bounded on the north by East Sixth Avenue, on the south by Broadway, on the west by Glen Drive and on the east by Keith Drive.

The new campus is needed to accommodate the 3,000 VCC students currently attending the King Edward campus on Oak, which is needed for expansion of the Vancouver General Hospital.

Council okays relocation of college to China Creek

The long search for a new site for the King Edward campus of Vancouver City College ended Thursday night when city council approved relocation of the college to China Creek on East Broadway by a 5-4 majority.

An 1,800-student campus will replace the wooden cycle track built on a former garbage dump in 1954 for the Commonwealth Games and will also displace

a small manufacturing plant.

The college sought rezoning of three square blocks of mostly vacant land zoned for industry and multiple dwellings, a block west of Clark Drive, between Broadway and 6th Avenue.

The campus must move from its present site at 12th and Oak to make way for Vancouver General

Hospital expansion.

The move had received reserved support from the surrounding community, which wanted the rezoning tied to guarantees of adequate parking and retention of the daycare centre currently on the King Edward campus.

The move was approved on a motion by Ald. Warnett Kennedy, who said it was on the understanding that space for a daycare facility would be incorporated in the plans. (However, completion of the daycare facility was not proposed in the motion.)

Ald. Harry Rankin proposed a motion that council commit itself to paying for the completed daycare

facility but the motion was lost.

Dan O'Reilly, spokesman for a local citizen's group, said there are many low-income, single-parent families in the area who would welcome the campus, but only if facilities existed on site which would make attendance for these people possible. He

added there are only three daycare centres in the area, each with a long waiting list.

Mary Bosze, a director of the Mount Pleasant Neighborhood Improvement Program, concurred. She told *The Province*, "We have 2,110 single parents (east of Main and south of 16th) with over 4,000

children.'

VCC board chairman W.A. Brown said the land for the daycare is available in the present plans, but is contingent on city council coming up with about \$250,000 for construction costs. He said VCC requested department of human resources for the money, but was turned down.

The daycare centre on King Edward campus the only centre in Vancouver licenced to look after infants — was set up to encourage parents to return

to school


Parking facilities were also discussed at length. Residents of the China Creek neighborhood expressed concern that inadequate parking provisions would result in crowded street-parking.

The original plans called for only 350 parking

stalls which was raised to 540.

VCC has already agreed to make arrangements to allow the general community to use the recreational facilities when they are not required by students, says a report from the city director of planning.

The functions of the present King Edward campus — high school completion, English language training, homemaking, courses for deaf people — in addition to some vocational courses will be offered at the new campus. The campus will be constructed in three phases but only the first two steps, which involve building a two-storey building then adding a third storey, were considered Thursday.


