COLLEGE BOARD

The Vancouver Community College Board met in regular session Wednesday evening, November 12th. Eight of the nine Board members were present.

The College Principal's report - a copy of which has been placed in the library - included mention of the following items: supervised field experiences for two U.B.C. graduate students at K.E.C., and the involvement of Chian-Li Hsu and Rose Marie Watson at a Toronto symposium on second language provision for adult refugees.

After lengthy discussion, the Board passed the following motion:

"That the Vancouver Community College Board request authorization from the Ministry of Education to go to tender for the construction of the King Edward Campus project and to award contracts on the basis of a 1980 third quarter estimate for construction and fees, presently not anticipated to exceed \$20,237,260, which is directly traceable to the previously approved 1979 third quarter base budget of \$17,118,000. It is understood that the project as initially conceived and approved can be built within the budget parameters outlined above, to be further adjusted at the time of actual contract award to reflect cost escalation from 1980 third quarter."

Additionally, the Board passed an additional motion on the provision of day care facilities:

"That the Vancouver Community College Board authorize architectural plans to include provision for a child care facility within the already established physical parameters, at an additional cost of \$120,000, on the expectation that the sum of \$100,000 will be provided by the Ministry of Human Resources and the remainder through the private pledge of \$20,000 already committed."

Thirdly, in order to save on increased costs on the V.V.I. building project resulting from inflation, the Board passed the following motion:

"That the Vancouver Community College Board request authorization from the Ministry of Education to expend an additional \$125,000 (1980 third quarter) for the temporary relocation of Auto Mechanics and Diesel programs upon the Chine Creek site."


The Board's present lease of our facilities at 12th and Cak has

been extended to April 1, 1982. The question concerning the period between April 1st and September 1, 1982 - our expected occupancy date of the new facilities on East Broadway - has yet to be addressed.

One of the concerns expressed by faculty at the time (1978-79) of our institutional evaluation related to the College's practice of selecting administrators. The College Executive Committee addressed the matter and, with input from the two faculty associations and the administrators' group, a policy and procedure was developed. At Wednesday's meeting, the document entitled "Selection of Administrators" was approved.

Reports and background material related to the Board's agenda, as well as the minutes of the Board meeting of October 22nd, have been placed in the library for the perusal of those interested.


