

# COMPUTERS IN EDUCATION

# Minnesota Increases Computer Education Effort

The Minnesota state government has enhanced its leading role in support of computer education by passing the Technology and Educational Improvement Act. The law in part:

- Provides for subject area in-service training in mathematics, science and social science.
- Encourages each school district to develop a technology utilization plan. A school district which applies for aid shall receive \$.75 times average daily membershp for 1982-83 school year. Model plans will be developed by the State Department of Education in consultation with other groups already involved in instructional computing.
- Permits each school district with an approved technology utilization plan to apply for state aid to provide in-service training on the use of technology in education in the amount of \$1 times average daily membership for the 1982-83 school year.
- Directs the state board to designate eight to ten districts as technology demonstration sites and award each district a grant before February, 1984. Total funds equal \$1,600,000.
- Directs the Department of Education to compile a list of high quality courseware. Schools purchasing these recommended materials will receive state aid equal to the lesser of \$1.60 times average daily membership or 25% of the actual expenditures for the purchase or lease of courseware.
- Authorizes the Minnesota Educational Computing Consortium (MECC) to develop and design courseware packages which might otherwise be too expensive or unavailable for schools in the state to purchase.

# <u>Two Million</u> <u>Microcomputers in</u> <u>Public Schools!</u>

TALMIS's most recent study, "District Level K-12 Purchasing Patterns," predicts two million microcomputers in U.S. public schools by 1988—an average of about 20 per school. In 1980, public schools had fewer than 40,000 microcomputers. As of June, 1983 the

installed base was 291,000.

Says Anne Wujcik, director of research at TALMIS, "We've been watching for some leveling off point in school microcomputer buying over the last two years, and we finally seem to see where it might plateau." The TALMIS study indicates that new microcomputer sales to schools will plateau temporarily around 1987. Nearly all school districts will then own at least one microcomputer, and most schools will have at least one microcomputer lab of 20 to 30 stations. Some elementary schools, however, are departing from this emerging pattern by placing a few microcomputers in each classroom instead of positioning all in a lab.

TALMIS has found that most schools are building up their microcomputer resources until they have enough to teach computer programming or literacy to their students. According to Wujcik, "Although software is getting better, computer education purchases will level off around the 1986-87 school year unless software developers produce compelling software that really helps teachers integrate computers into their ongoing curriculum. The key to computer use in schools is that teachers know what to do with them."

The TALMIS study reports a good possibility that schools may reach the one child, one computer stage if appropriate software and/or hardware is available.


