

#### POLICY:

A.1 The mounting or affixing of signs - both temporary and permanent - shall be in accordance with "King Edward Campus Guidelines for the Mounting and Affixing of Signs", as noted hereunder.

#### PROCEDURES:

### King Edward Campus Guidelines for the Mounting and Affixing of Signs

- B.1 In order to be posted on campus notice boards, permanent and temporary signs must bear the approval of the Dean of Administrative and Student Services or his delegate.
- B.2 When it is determined that a permanent sign is required, the division chairman, department head or program/service coordinator will forward the request to the Building Services Manager who with the approval of the Dean of Administrative and Student Services or his delegate shall undertake to have the requested sign placed.
- B.2.1 Permanent signs designating the function of an area or a room shall be suspended from the ceiling in proximity to the appropriate doorway(s) or affixed to the wall above the appropriate doorway(s).
- B.2.2 Signs identifying office occupants and their hours shall be located adjacent to the appropriate office doorway(s).
- B.3 Notice Boards will be strategically located throughout the campus to accommodate temporary signs and notices.
- B.3.1 When it is determined that a temporary sign is required, the division chairman, department head or program/service coordinator will forward the request to the Building Service Manager who with the approval of the Dean of Administrative and Student Services or his delegate shall undertake to have the requested sign placed.
- B.3.2 Normally, temporary signs shall not be placed on walls, doors or windows.

# PLEASE NOTE THE FOLLOWING:

- 1. STUDENTS WHO HAVE REGISTERED AND PAID THEIR TUITION FEES IN ADVANCE, WILL RECEIVE A FULL REFUND LESS A \$20.00 REGISTRATION FEE IF THEY WITHDRAW PRIOR TO THE FIRST DAY OF CLASS.
- 2. THE STUDENT ACTIVITY FEE IS NON-REFUNDABLE AFTER THE FIRST DAY OF CLASS, UNLESS THE SINGLE COURSE FOR WHICH A STUDENT HAS REGISTERED IS CANCELLED THEN A COMPLETE REFUNDIS ISSUED.
