POLICY:

- A.1 Adult Canadian citizens including permanent residents in Canada ("landed immigrants") are eligible for enrolment at Vancouver Community College.
- A.2 By exception, those whose status in Canada falls within one or more of the following categories may be considered for enrolment as though they were Canadian citizens or permanent residents in Canada, including:
- a) persons who have applied for permanent status and whose application is receiving favourable consideration;
  - b) diplomats resident in Canada as a consequence of their diplomatic assignments, and their dependants;
  - c) a non-permanent resident who is a dependant (spouse, child or parent) of a Canadian citizen or permanent resident in Canada;
  - d) a person being processed under the Foreign Domestic Movement program (FDM);
  - e) persons and their dependants who, as a condition of their employment, will legally reside in Canada for a period of not less than six months; and
  - f) students who are sponsored for studies in Canada by a service organization registered under the British Columbia Societies Act.
- A.3 All other non-Canadian students, for purposes of enrolment consideration at Vancouver Community College, will be governed by College policies specific to International Education students.

Title: CITIZENSHIP - ELIGIBILITY  
FOR ENROLMENT CONSIDERATION

PROCEDURE:

- B.1 All documents relating to proof of citizenship and/or status in Canada may be required at the time of application for enrolment in the College.
- B.2 If required, enrolment status will be determined by the respective campus Dean of Administrative and Student Services, or his delegate, when applications are being considered.
- B.3 Each campus shall keep a record of the individuals admitted under the exceptions provided for in A.2 and the item of College policy used as the basis for making the exception.

POLICY:

- A.1 All persons not eligible to enrol under College Policy No. 2.1.2.3 will be considered for international student status.
- A.2 If admission is granted, all international students and/or their dependants must pay all costs, direct and indirect, for education and related services received at Vancouver Community College. Such costs will be set in accordance with the College Policy on Cost-Recovery Courses/Programs" or as determined by the College's International Education Committee.

PROCEDURE:

- B.1 At time of application for admission to Vancouver Community College, international students must present proof of academic qualifications and proof that they are legally in Canada.

PREAMBLE:

Subject to Part 4: Article 2 (c) of the College and Institute Act, "the board has power and duty to ..... determine all questions relating to the qualifications for admission and continuation of instruction of a student at the institution."

POLICY:

- A.1 All Canadian citizens and permanent residents above British Columbia school leaving age are admissible to Vancouver Community College.
- A.2 Non-citizens and non-residents in those categories as outlined in Policies 2.1.2.3 and 2.1.2.4 are admissible to Vancouver Community College.
- A.3 Admission and re-admission requirements for specific courses/programs are based on the underlying principle of the potential for success, within the time limits of the specific courses/programs.
- A.4 Admission to a specific course/program is normally on a first-come first-served basis provided that all admission requirements are met. In other cases, admission is granted only after a successful interview, audition and/or the presentation of a portfolio, where appropriate.

PROCEDURES:

- B.1 Admission requirements for specific courses/programs are set out in the calendars of the campuses/centres of the College.

POLICY:

- A.1 Tuition fees are due and payable in full upon registration. They may not be deferred except under special circumstances: for example, pending receipt of student loans and/or grants; sponsorship by an external agency, in which case the student will not be required to pay a deposit; etc.
- A.2 Other than provided for in A.1 above, full payment of tuition fees may be deferred upon authorization of the Dean of Administrative and Student Services, or delegate. Normally, students requesting deferrals will be required to pay a deposit, the amount of which will be determined by the Dean, but which, generally, will not be less than 25% of the fees payable. The deposit will be non-refundable, but it will be deducted from the full amount of tuition fees owed to the College.
- A.3 In exceptional cases, students with no financial resources - and who have no prospects of obtaining support or sponsorship - may be referred by the division chairmen to the Dean of Administrative and Student Services, or delegate, for extraordinary consideration for assistance, albeit only to the extent that special bursary/loan funds will permit.

PROCEDURES:

- B.1 Students wishing to have their fees deferred will complete the Fee Deferral Form. (See attached.)
- B.2 For students requesting fee deferrals pending receipt of their student loans or grants, confirmation thereof must be obtained from the Financial Aid Advisor prior to authorization of the deferral.
- B.3 At the discretion of the Dean of Administrative and Student Services, or delegate, students may be required to provide post-dated cheques for the full amount of fees, less the deposit which may already have been paid. Cheques will be processed by the Supervisor of Registration Services, as they come due.
- B.4 Cards will be processed.
- B.5 Students who have not paid outstanding fees in full by the approved deferred date, or arranged for a further deferral, will be suspended from classes until tuition is paid.

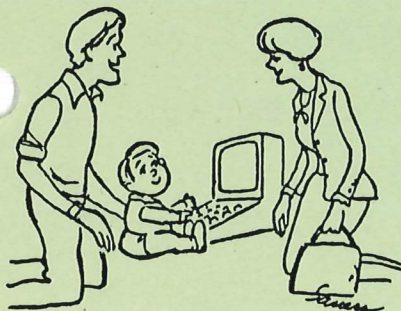

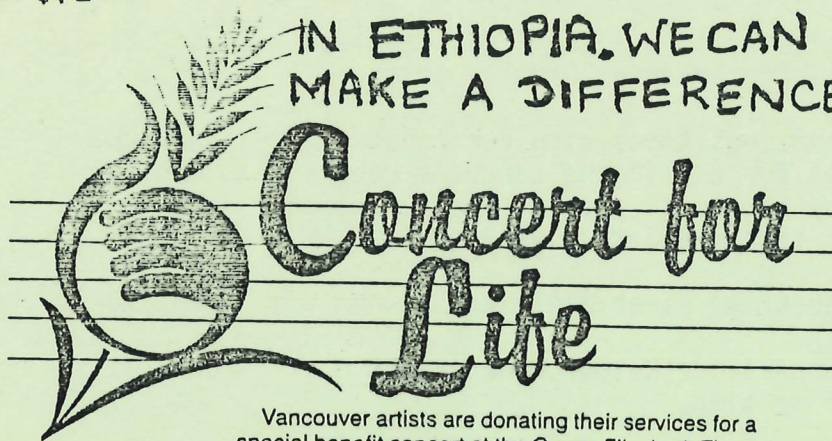
