Allocations: 'excellence' and 'operating'

Projects, programs specified

Allocations totaling some \$14,000,000 to British Columbia's colleges and institutes from the Fund for Excellence in Education were announced on June 18 by Minister of Post-Secondary Education Russell G. Fraser.

These allocations supplement the \$7,300,000 worth announced in May and are the last scheduled, bringing the college-institute share of the \$110,000,000 fund to about \$28,000,000.

The allocations are earmarked for specific programs and projects, based on varied institutional submissions that range from new computer-related programs to manufacturing. They also include varying amounts for equipment upgrading.

Another \$4,000,000 has been provided for two overall undertakings: \$2,000,000 each for a consortium designed to enhance and upgrade computers, including trading among institutions, and an equipment incentive fund, designed to ensure student access to specialized equipment.

By institutions, the final allocations and a sampling of projects are as follows (see adjoining table for Excellence Fund totals for each institution as well as overall operating funding announced at the same time):

CAMOSUN: \$509,400; develop and mount welding and industrial fabrication technology training program.

CAPILANO: \$486,200; computerized "Centre for Achievement and Excellence" serving all students.

CARIBOO: \$459,300; automated design and graphics centre.

DOUGLAS: \$400,500; first phase of Maple Ridge community education centre.

EAST KOOTENAY: \$268,000; creation of a college-community interactive learning centre.

MALASPINA: \$346,800; first phase of project to develop computer skills in all instructional staff.

NEW CALEDONIA: equipment for second year of electronics program.

NORTH ISLAND: \$360,900; continuation of new computer-based learning process.

NORTHERN LIGHTS: \$348,200; training program in small scale fibreglass and plastics manufacturing.

NORTHWEST: \$110,600; automatic radar and plotting apparatus for marine training programs.

OKANAGAN: \$425,700; business development centre.

SELKIRK: \$239,300; expansion of graphic communications program.

EMILY CARR: \$382,400; re-establish mobile art studio to take art training to the Interior.

KNOWLEDGE NETWORK: \$920,000; purchase of new educational television programs.

OPEN LEARNING INSTITUTE: \$226,000; further development of program enabling non-native speakers to reach basic proficiency in English.
