REMEMBRANCE DAY - 1986 RECEIVED NOV 7 1986

It was at eleven o'clock on the eleventh day of the eleventh month that an armistice was declared and World War I was over. Considerable jubilation resulted in the certainty that the "war to end all wars" had finally brought about peace in the world; but it was not to last for too long. I recollect that, for several years before WWII began - not even 21 years after the armistice had been signed - we observed November 11th every year at my elementary school - almost as a divine service - singing our National Anthems - at that time it was - "God Save the King" (not "the Queen") - reciting "In Flanders Fields" listening to a mini-sermon and prayers delivered by the local Royal Canadian Legion padre, and probably singing as well "In Days of Yore from Britain's Shores." For me, it was always intensively moving. (But we didn't have a holiday from school.)

Today, sixty-eight years after 1918, we still observe the 11th of November, but now as Remembrance Day, remembering those who made the supreme sacrifice, not only during the 1914-18 conflict but also during subsequent wars and peace-keeping missions, to preserve our freedom and bring about peace and freedom elsewhere in the world. (And today, November 11th is a general holiday.)

King Edward Campus will be closed on Tuesday next, November 11th. Please remind your students. Regular classes will resume on Wednesday, November 12th.

POLICY:

- A.1 Tuition fees are due and payable in full upon registration. They may not be deferred except under special circumstances: for example, pending receipt of student loans and/or grants; sponsorship by an external agency, in which case the student will not be required to pay a deposit.
- A.2 Other than as provided for in A.1 above, full payment of tuition fees may be deferred upon authorization of the Dean of Administrative and Student Services, or delegate. Normally, a student requesting deferral will be required to pay a deposit, the amount of which will be determined by the Dean, but which, generally, will not be less than 25% of the fees payable. The deposit will be non-refundable, but it will be deducted from the full amount of tuition fees owing to the College.
- A.3 In exceptional cases, students with no financial resources - and who have no prospects of obtaining support or sponsorship - may be referred by the division chairmen to the Dean of Administrative and Student Services, or delegate, for extraordinary consideration for assistance, albeit only to the extent that special bursary/loan funds will permit (refer to policy 2.2.1.5).
- A.4 Under extraordinary circumstances the Manager of Admissions, Registration and Student Records Services (or delegate) may defer fees for twenty-four hours.
- A.5 A student who neither has paid outstanding fees in full by the approved deferral date nor has arranged for a further deferral, will be suspended from classes until tuition fees are paid.

PROCEDURES:

- B.1 A student wishing to have tuition fees deferred will complete the Fee Deferral Form. (See page 5)

PROCEDURES: (continued)

- B.2 At the discretion of the Dean of Administrative and Student Services, or delegate, students may be required to provide post-dated cheques for the full amount of fees, less any deposits paid. Cheques will be processed by the Manager of Admissions, Registration and Student Records Services.
- B.3 Course cards will be processed where and when appropriate.



SUBJECT: ERIC RESOURCE AT KEC

Re your memo of 1986 October 29 questioning how the College is involved in ERIC and in the ERIC Microfiche Programs particularly, we (i.e. the College libraries) receive the indexes to the entire ERIC collection - reports and journal articles. We also have access to the computerized indexes in Colorado and California. The libraries undertake searches - manual or computerized - on request - four or five a month (mostly for VVI) and on identification of an article or report, retrieve the document from one of three sources. We can get a duplicate fiche item from UBC (who has the entire file) in a day or so. We can get either fiche or hard copy from California in a week or so (depending on mails) and, finally, we can get an extensive abstract on-line from one or other of the data bases we use.

We also file reports and other documents with ERIC from time to time.

EXCERPT FROM LETTER FROM SHANNON HOUGHAM OCT. 14/86

"We have a 50 gallon tank in the kitchen that gets filled up on Monday and Friday. That is the only water in the house but it is not really a problem, quite easy actually. We keep two large kettles full of water on the wood stove for dishes and the wood stove has a 5 gallon tank on it. That means we always have warm or hot water to wash with. We shower at the school. I don't think we'll be down for Xmas. Xmas here sounds unique and we'd like to experience it. Apparently on New Years everyone here shoots off guns and rifles - should be interesting.

The store here gets fresh fruit and veggies but boy are they expensive. \$3.00 for a head of lettuce. What we do is phone Yellowknife with our order, Yk foods, they pick out food and send it up on the plane. We always have fresh fruit and veggies here. Quite a pleasant surprise. Whoever picks out our food does a good job. For example we asked for bananas so they sent some ripe and some green.

We run up here with the couple from New Zealand. Actually he's from NZ she's from England. We don't go too far from town because of the bears but we run down the air strip then over to the micro wave dish and back along a path on the ridge of a hill and back to town. This life seems to agree with me. All the constant movement, stoking fires and baking all the time and carrying buckets of water outside has trimmed off 10 lbs. or so - no scales up here but it feels like that.

We really lucked out as far as bugs are concerned. We missed them all! We've had lots of snow but it keeps disappearing again. I can't wait for a real snow fall, should be fun.

The wolves here don't howl as there are no wolves but the dogs howl at night. Especially when the Northern Lights are out. One night they were unbelievable. Green, blue, yellow and pink and huge. I've never seen anything like it.

No grizzly bears but black bears come into town. We've never seen any but we bought a bear skin from one of Ted's students who shot a bear that was in town last year. I'm going to get a tanning kit and make a rug out of it as its quite large.

Yesterday, a young retarded, maybe down's syndrome, man died. He was complaining of pains in his chest and they were going to get the lay dispenser to phone the doctor but he died before they got to her house. The R.C.M.P. heard about it and phoned Mel, the store manager, to go check to see if it was true and to see if there was foul play or anything. They (RCMP) are trying to get here today but the weather is bad so they may not make it in. Meanwhile the RCMP don't want the body moved so its still in their house. They (the family) want to move the body to the church but RCMP said no. Can you imagine having a dead body around for a few days in a warm house - no thanks! We don't know the boy or the family so it really doesn't concern us but the process is fascinating. Someone will have to sign a death certificate and all but he'll have to be buried soon as there are no embalmers here.

It is amazing how normal life up here seems now. Although at first it took some getting used to - seeing plices of caribou all over the place. There was a caribou hoof and leg on the store steps for about a week. When the snow comes it will cover it all up."






OPPORTUNITIES FOR PROVIDING CONSULTANTS FOR THE INTERNATIONAL LABOUR OFFICE

In mid-September, the Ministry arranged for Mr. John Whitehouse, the Director of the Canadian branch of the International Labour Office, to address post-secondary institutions in British Columbia on the opportunities and procedures for providing consultants for ILO projects. These positions frequently provide base salaries of \$40,000 US with tax benefits, housing and transportation allowances. Consequently, they may be of interest to some of you for professional development opportunities as well as providing an opportunity for the College to strengthen ties with other countries.

The International Labour Office in Ottawa has indicated its preference in using our Ministry as a mechanism for distributing information on projects to interested parties in British Columbia. The Ministry will be forwarding to the College, on a regular basis, the ILO quarterly report outlining the list of vacancies in technical cooperation projects. The July issue is a sample personal history form which should be completed by those who are interested in a specific vacancy or registering with the ILO personnel roster. The final decision on the candidate will be made by the national government.


