NOTES FROM THE MANAGEMENT COMMITTEE MEETING, 1987 JANUARY 19

At its regular meeting on Monday, January 19th, the Management Committee of the campus addressed the following items:

- the chairman reported that he had forwarded to the President the names of three administrative staff who would be interested in attending the Pacific Management Training Institute.
- Sam Lewindon presented a brief report he had been asked to prepare on the advantages and disadvantages of having division chairmen remain in the VIA.
- Gordon Pawelchak presented a proposal he had been asked to prepare for the formation of a Campus Organization Committee. This committee, when completed, will be asked to review the administrative structure of the campus in view of the retirement of the Dean of Instruction to make recommendations for changes, if necessary.
- there was discussion about the principal's request to move his office to an area nearer the front entrance of the administrative area to make the office more easily accessible to students and faculty.
- Terry Smith reviewed the fund-raising efforts of the Music Department to prepare for the "Soundwave European Tour." The department was asked to proceed with travel arrangements on the understanding that the trip must not incur a deficit.
- there was a short discussion about a new policy relating to the attendance requirements for CEIC-sponsored students. A few revisions are needed.
- there was discussion about the hiring of a Manager for the Assessment Service. More action will follow on this item.
- the chairman began a brief review of "Major Questions for Consideration" as listed in the agenda for January 12th.
- Dorothy Moutter requested clearer information on office hours of division chairmen.


The meeting adjourned at 15:15 hours.




