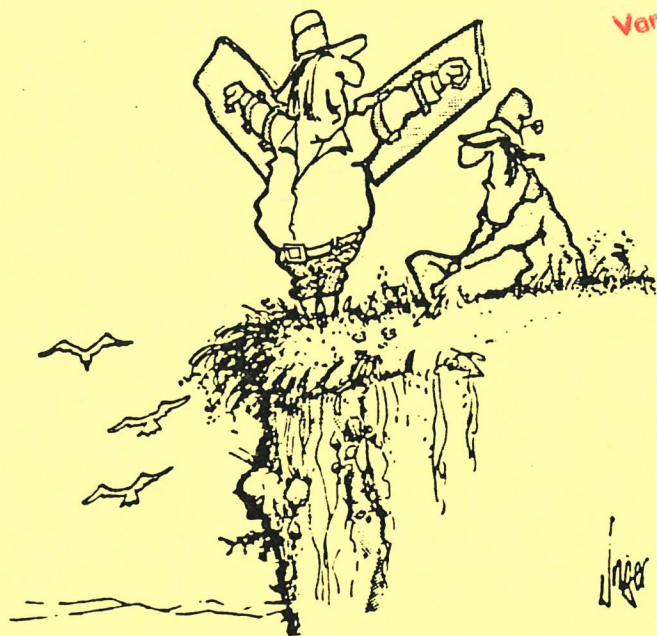

COMPLIANCE WITH CITY HEALTH
BY-LAW 4387 - (RESTRICTED
SMOKING)
Concerning: Faculty, Staff and Students

To comply with the City of Vancouver Health By-Law on smoking which is now in effect, King Edward Campus will be classified as "Smoking is Permitted Only in a Designated Smoking Area". (Health By-law 4387 and the amending By-law 5994.)

POLICY

- A.1 The areas designated for student smokers will be:
- (a) approximately 50% of the student dining room
 - (b) 2 student lounges, rooms 2117 and 3198
 - (c) approved designated areas in the mechanical trades area on level one
- A.2 The areas designated for staff/faculty smokers will be:
- (a) room 2142 (part of the staff/faculty dining room)
 - (b) private offices (if the following conditions are met)
 - i) that the office be free of smoke when students are being interviewed, counselled or tutored
 - ii) that smoke does not drift into common hallways or other offices
 - iii) that there are no complaints from other users of the area
 - iv) that the nicotine level meets standards set by the Vancouver Smoking By-Law
 - v) that ionizers or other machines purchased by the individual to eliminate smoke in a given office be suitable to reduce the nicotine level
 - vi) that there be sufficient ventilation directly to the outside of the building

PROCEDURES

- B.1 Students, faculty and staff who are found violating the by-law will be given warning in writing by administration or delegate.
- B.2 Students, faculty and staff who continue to violate the smoking by-law may be subject to further disciplinary action on the part of the College.

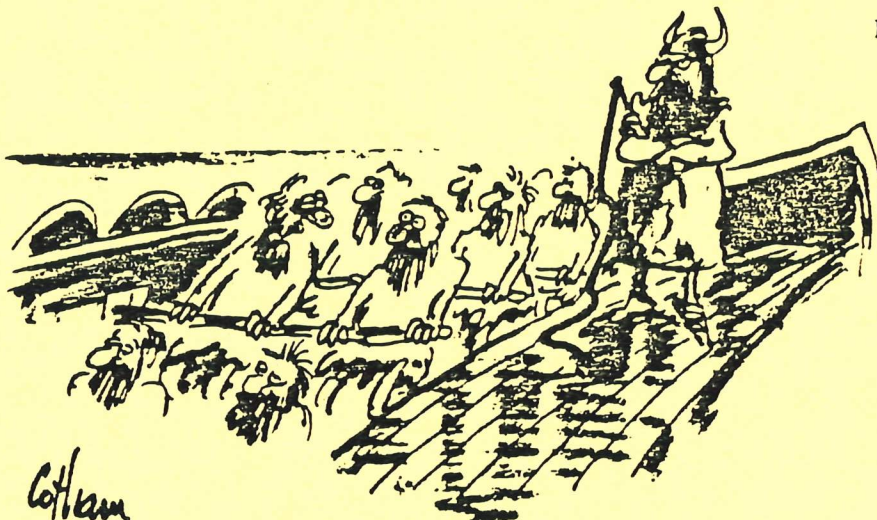

THE CATHAY INTERNATIONAL TELEVISION (CITV) PROJECT

As a follow-up of the CITV's proposal to produce a series of instructional programs to teach English language to their viewers, a number of meetings were held between KEC and CITV in March and April. A Production Proposal was approved by the KEC Management Committee on May 4, 87. To confirm details regarding copy-right, the Principle and the ESL Division Chairman met with Mr. Brian Sung, the President of CITV on May 12. Both parties agreed to launch this joint venture with the following understanding:

1. This project will be a pilot project lasting three months on air, showing a total of 39 modules at a frequency of three times a week in June, July and August. Each module will be about eight minutes long. The target audience will be upper beginners. Should this succeed in generating interest, a Phase II will be developed. Funding from government sources will then be sought.
2. CITV will be responsible for the production of the 39 modules with the presenter and material supplied by KEC. The printed text and exercises will be printed by KEC and distributed free through the two CITV offices, the three VCC Campus libraries and School Canadiana in Chinatown. A Participation Certificate will be awarded to viewers for encouragement.
3. Alice Wong will be released from some of her SEED duties to be the presenter and co-ordinator.
4. No other Chinese T.V. companies in North America except Cathay International T.V. Inc will have the right to show the series. KEC will have the right to use all material developed for educational purposes.
