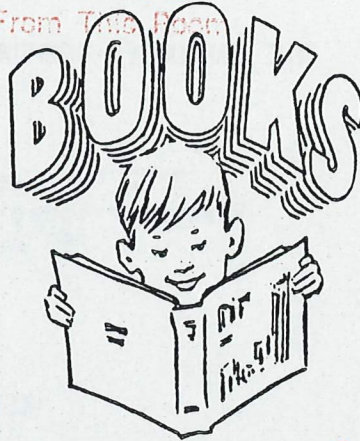

3. 8 1/2 x 14 7/8, 1 pt. Tinted Bar 431F
4. 9 1/2 x 11, 1 pt. Letteredge, Blank
5. 9 1/2 x 11, 1 pt. Blank (draft)
6. 11 x 14 7/8, 1 pt. Lined
7. 11 x 14 7/8, 1 pt. Blank

If we are not stocking the type you require please let Steve Baker know, and he will order a supply in. Do not order your paper through the Computer Center or the Purchasing Department. Please order through the Receiving Department.

Other Supplies:

A reminder from the Receiving Department. All requests for supplies from the Receiving Department should be placed on a "supply order" form. The orders will be filled as soon as possible, however, incoming shipments do get priority. Please do not drop by or make requests by telephone as this causes more delays and effectively backs up the daily schedule. The maximum time for completing a supply order is usually no more than three working days. Try to organize supply requests to accomodate the three day delivery time.

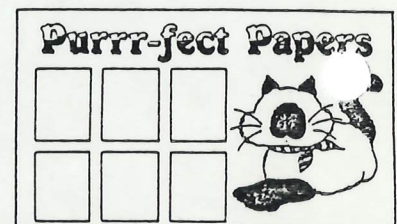
Outgoing Shipments:

When you require something to be shipped out please remember the following rules:

1. If it is small enough to fit in the mail, send it through the mailroom.
2. If it is too big but light enough to carry, bring it to the Receiving Department.
3. If it is too big and heavy you can call the Receiving Department and arrange for it to be picked up during the afternoon deliveries.
4. For rush items you may arrange to borrow a trolley and move it yourself.

Anything going by courier should have the address labelled on the box. All prepaid shipments must include the department number.

Your co-operation and assistance is appreciated by your receiver.



Sample letter from employers to employees

As you are aware, the federal government has introduced a series of reforms to Canada's tax system. Tax Reform will come into effect for 1988 and will be reflected in payroll deductions starting July 1.

Most Canadians will pay lower taxes because of two changes: a new structure of federal income tax rates (the present 10 tax brackets have been reduced to three, with the top federal rate lowered from 34 per cent to 29 per cent); and personal exemptions and many deductions have been converted to non-refundable tax credits.

Essentially, this is a fairer system, as credits directly reduce the amount of tax you must pay. Also, each credit will be worth the same amount for all taxpayers, regardless of their income level.

To reflect these changes, Revenue Canada Taxation has designed a personal tax credit return (TD1). This new TD1 form will provide current employee information upon which the correct amount of income tax withholdings may be determined and deducted from your pay.

It is important for you to complete a new TD1 before July 1, 1988. This will ensure that your tax credits are accurately reflected in the income tax deducted from your pay. If you do not complete a new TD1 form, your income tax deductions will only reflect the minimum credit which is allowed to a single person with no dependants. In addition, you should be aware that space has been provided on the TD1 for individuals with other sources of income to increase the amount of income tax deducted from their pay. If you would like to increase your income tax deductions, please complete line 15 on this form. A TD3 form (Request for Tax Deductions) is no longer required.

In the future, whenever your situation changes and you wish to update the information on the form, you should complete another TD1. This will ensure that your income tax deductions remain accurate.
