AN L.D. TIDBIT...

Despite the passage of Section 504 of the Rehabilitation Act of 1973, there is still controversy over "reasonable accommodations" for students with learning disabilities (LD) in higher education. Some of this controversy centres around extra time on exams.

A study was conducted at the University of California, using the Nelson-Denny Reading Comprehension and Reading Rate Test. Percentile ranks were obtained for reading rates on individuals, and for comprehension scores under timed and extra-time conditions. The major findings of this study were that there is a significant difference between scores obtained by students with learning disabilities and by normally achieving students under timed conditions. However, there are no significant differences in test performance between students with learning disabilities and normally achieving university students when students with learning disabilities are provided extra time. Normally achieving students did not perform significantly better with extra time.

At a northwestern college, faculty in the colleges of Business, Education, and Arts and Science were asked to respond to a questionnaire devised to assess faculty willingness to provide students with LD special accommodations. These accommodations included extra time on exams. Results indicated that 85% of the faculty members were willing to provide students with learning disabilities extra time on exams.



ICSC COMPUTING CORNER

Purchasing a Computer - 1

Reading the Advertising



Computer advertisements are not *meant* to be confusing. However, they are sometimes difficult to understand. Perhaps this page will help. This is a typical computer ad with an explanation of the terminology.

386-25MHz The 386 refers to the 80386 processing chip which is the brains of the computer. You will see advertisements for a 286, which is a smaller brain, or a 486, which is larger. Most new software is designed with the 386 in mind, but the major word processing and spread sheet packages will run on less powerful systems, just more slowly. The 25MHz stands for "25 megahertz" and refers to clock speed. Usually higher clock speed means faster processing. A 386 running at 25 MHz is faster than a 386 running at 16MHz.

40MB Hard drive

You can store all your software and your work on the hard drive. This hard drive can store 40 megabytes,

which is roughly equivalent to 40 million typed characters or about 400 thousand typewritten pages. The more data the hard drive holds, the more you ususally pay for it.

1MB RAM — This refers to the computer's internal memory. Some software requires a lot of memory. This computer has 1 megabyte of memory. This is sufficient for most word processors or spreadsheets. Many older computers have less. People who work with desktop publishing, or other programs using a great deal of graphics, need 4, 6 or even 8 megabytes of memory. Those who install WINDOWS on their computer, should consider 4 megabytes of RAM.

2400 baud modem Modems allow computers to send data through the phone lines to another computer. 2400 baud refers to the speed at which the data travels through the phone lines. 1200 baud is slower

1.2 or 1.44 Floppy Drive 1.2 or 1.4 refer to the size of the floppy disk drive in this computer. 1.2 means that the disk holds 1.2 megabytes of data and is probably 5.25" in size. 1.44 means 1.44 megabytes and is 3.5" Both are High Density disks and cannot usually be used on older computers.

14" Colour VGA monitor 1024x768.28mm — 14" refers to the size of the monitor (measured diagonally.) Colour screens are popular, but gray scale (shades of gray) are also good.1024x768 refers to the screen's resolution, how clearly defined the characters appear. This screen contains 1024x768 pixels, points of light, which are .28 millimetres apart. The more pixels and the closer together they are, the higher the screen resolution.

Mouse — A mouse is a palmsized device which is used to manipulate characters on the computer screen. A mouse is especially useful when working with WINDOWS.

Microsoft Windows—This software package allows you to use pictures called ICONS to manipulate your computer. The user can point to an icon or command on the screen, and click a button on the mouse, and this has the same effect as typing in a command. Many people fing this easier to use than the older method of typing in all commands.

ETHICAL ENCOUNTERS FOR COLLEGE PERSONNEL

This 3 hour workshop is designed for faculty, support staff, administrators and board members in community colleges and will be conducted in three parts.

The introduction involves a discussion of current concerns in the professions, business, government and the educational community over questions of ethics, moral conduct and decision making in a multicultural society. This will be followed by a brief exploration of the major theories of ethical behaviour.

The second part of the workshop will focus upon the area of post-secondary education and will examine the predominant values which sustain and direct the resolution of issues such as accessibility, quality, academic freedom and authority in community colleges. Participants will be asked to respond to a set of value statements which embody the values under review.

Finally, participants will break into small groups to discuss and debate a number of cases which involve ethical dilemmas and conflicting values. There will be further opportunity for each group to report on the cases and their resolution to the group at large.

The workshop is designed to involve maximum participation by all present.

Your workshop leader will be John D. Dennison, Professor of Higher Education, UBC. Dr. Dennison offered this workshop through HRD last year. It was a resounding success and we are very pleased to welcome him back.

NOTICE TO ALL MEMBERS AND PROSPECTIVE MEMBERS V.C.C. EMPLOYEE BENEFIT PLAN

The Vancouver Community College Employee Benefit Plan was established in late 1985 to provide a vehicle whereby plan members/eligible V.C.C. employees could defer a portion of their monthly income for the purpose of financing a future sabbatical leave or supplementing their retirement income. Amounts contributed to the E.B.P. were not subject to income tax until such time as payment is received by the individual from the plan in accordance with an advance tax ruling given to the plan by Revenue Canada in March of 1985.

Subsequently the Government of Canada amended the Income Tax Act to effectively disallow tax deferral except where the purpose of the deferral was to finance a future sabbatical leave. This effectively eliminated the "retirement supplement" purpose of our Employee Benefit Plan.

Your Plan Administration Committee is advised that, to ensure compliance, our plan need not be amended provided that future contributions are designated for sabbatical purposes only. Salary deferral for retirement supplement is no longer allowable effective July 1, 1986.

All current plan members who were contributors to the plan as at August 1, 1986 are required to withdraw monies subsequently deferred to finance their sabbatical leave. Such leave must commence within six years which means you should be finalizing your sabbatical leave plans to begin sometime during the calendar year 1992. Plan rules do allow for limited extensions where absence from duty cannot be accommodated. In such instances a minimum deferral to 1993 would be allowed.

All present and prospective plan members/contributors who wish to defer a portion of their 1992 income for the purpose of financing a future sabbatical leave must file with the undersigned, newly completed and signed Letters of Agreement covering the calendar year 1992. The member's Letter of Agreement must be submitted no later than December 23, 1991 and shall designate for each month of the calendar year 1992 the amounts to be deducted from remuneration for that year. Plan membership and contributions by payroll deductions for the calendar year 1992 may not be authorized and accommodated after the foregoing deadline, December 23, 1991.

Contributing members may, under special circumstances with the approval of the Plan Administration Committee, supplement or amend by written agreement their designated contributions.

Full details governing the plan are found in the "Plan Rules" with a brief description also available from the Employee Relations Office along with the necessary forms (Letters of Agreement) to facilitate your 1992 enrolment. Enrolment forms have been provided, under separate cover, to current plan members.

The Trusteeship of the plan will remain with Canada Trust. We are assured of continued high level of quality service as Canada Trust has been a recognized leader in the field for over 25 years. A new trust agreement with appended plan rules is in the final stages and will be executed on your behalf before the end of the year.

On behalf of the Plan Administration Committee, it is my intention to convene a general meeting of all plan members sometime in January 1992 to conduct the normal business of the plan and provide to each member a copy of the new Trust Agreement, plan rules and other descriptive materials.
